Call to Order and Pledge of Allegiance. Chair Johnson called the meeting to order at 5:30 pm. Members recited the Pledge of Allegiance.

Roll Call. Chair Johnson called the roll. A quorum was in attendance. Chair Johnson welcomed participants from our new member counties, Olmsted and Waseca.

Approve Minutes of January 8, 2024 Meeting. Chair Johnson noted some corrections to the January 8 minutes. Commissioner Bommersbach moved to approve the January 8, 2024 minutes as amended; Commissioner Veerkamp seconded. Motion passes.

Treasurer's Report. Secretary/Treasurer Commissioner Bring reviewed the financial reports and noted outstanding expenses. She also reported that the MRC balance is currently the highest that it has been due to onboarding of new members with expenses remaining steady relative to previous years. Commissioner Jensen moved approval of the Treasurer's Report and Financial Statement; Commissioner Gerde seconded. Motion passes.

Review of Priorities and Introduction of Legislative Speakers. Rob Vanasek and Sam Walseth gave updates on recent activities at the Legislature. Rob gave specific updates regarding MRC's 2024 Legislative Priorities. Significant activity going on in environment and natural resources committees. Sam also touched on Drainage legislation.

Sam introduced our Legislative Speakers, Senator Grant Hauschild and Senator Tou Xiong. Senator Xiong spoke to the issues that are in front of his committee, including reports from the Drainage Work Group. He noted that it is imperative that metro members work with rural members and understand greater Minnesota issues. He invited Commissioners to reach out, even if they are not his constituents. Senator Hauschild shared his perspective as a Rural member of the DFL Caucus and outlined legislation he is promoting this session. Discussion ensued, with the Senators taking questions from MRC Members.

Legislative Update, Continued. Rob and Sam gave further updates on bills that are moving forward that are of interest to Rural Counties. In particular, the County Administered Rural Medical Assistance (CARMA) bill is moving forward. Bill authors of that initiative will be invited to speak at the next MRC meeting. Anne noted that this may also be discussed at the upcoming AMC Health and Human Services Policy Committee.

Discussion/Sharing/Best Practices

MRC Members were provided the opportunity to raise any issues of importance or concern. A discussion was held regarding the proposed North Star sanctuary state legislation. Rob and Sam provided perspective based on legislative leadership's public statements that the bill will not move forward, which was also stated by Senator Hauschild earlier in the meeting. Counties also discussed how they are handling implementation of the new Minnesota flag and seal and the Drainage Work Group and related legislation.

Other

Rob noted that Britta Torkelson is on a leave of absence and that Anne, Sam and Rob are all available to assist MRC in any way needed. Anne reminded members to sign in for attendance purposes. The next MRC meeting will be held on March 4 via Zoom.
